**For Investors in the Short Maturity Sustainable High Yield Bond Fund (the “SMSHY Sub-fund”)**

“Early Bird” discounted investment management fees shall be available in the **SMSHY Sub-fund’s X1 and X2 Share Classes**.

**The SMSHY Sub-fund’s X1 Share Class** shall be open only to institutional investors beginning from the SMSHY Sub-fund’s launch date to (i) June 30, 2019 or (ii) the date in which the X1 Share Class reaches \$200 million or foreign currency equivalent in AUM (“dollar cap”), whichever date occurs first (the “Closing Date”). New and subsequent subscriptions made before and up to the Closing Date shall be charged an annual investment management fee of 11.25 bps (a 75% discount from the posted fee) until June 30, 2019. Beginning on July 1, 2019, unredeemed subscriptions in the X1 Share Class shall be charged an annual investment management fee of 22.5 bps (a 50% discount from the posted fee) until June 30, 2020. Beginning on July 1, 2020, subscriptions in the X1 Share Class shall be charged an annual investment management fee of 40 bps (an 11% discount) for as long as subscriptions are unredeemed.

Please note that once the X1 Share Class is closed due to occurrence of the scheduled end date or dollar cap, no new or subsequent subscriptions shall be accepted, but investors who have invested in the X1 Share Class before the Closing Date shall be charged the discounted fees in accordance with the schedule set forth above.

**The SMSHY Sub-fund’s X2 Share Class** shall be open only to institutional investors beginning on the launch date, and new and subsequent subscriptions to the X2 Share Class shall be charged 25 bps (a 44% discount) until October 31, 2019; 35 bps (a 22% discount) from November 1 to June 30, 2020. From July 1, 2020 the X2 Share Class will incur an annual management fee of 45 bps, which is the posted rate for the SMSHY Sub-fund’s A Share Class, and accordingly it is anticipated that remaining subscriptions in the X2 Share Class will then be switched to SMSHY Sub-fund’s corresponding Class A Share Class.

Notwithstanding the discounted investment management fees above, all investors shall continue to share proportionately in the Sub-Fund’s operating expenses (including but not limited to the Luxembourg subscription tax) subject to the SMSHY Sub-fund’s Total Expense Ratio (“TER”).
